
business contacts and referrals. WIT-LA's strength is the global expertise of our members who have a strong focus on planning and executing business opportunities involving international trade.




Alan Turley

Prior to re-joining the Commercial Service, Mr. Turley was Vice President for International Affairs in Asia Pacific for FedEx Express. Twice a winner of FedEx's coveted "Five Star Award", Mr. Turley helped manage FedEx's rapid growth and expansion in Asia, including the building of China's first international air express hub, the founding of FedEx's wholly-owned operations in China, and the approval of FedEx's purchase of TNT



xpress.

Mr. Turley's previous service in the U.S. & Foreign Commercial Service started in 1986 in Japan, where he head headed the Major Projects and Transportation Equipment Unit. Mr. Turley then served as the Director of the Commercial Service's International Marketing

Center at the U.S. Embassy in London before moving back to Asia to become Deputy Senior Commercial Officer at the American Institute in Taiwan.

From 1996 to 2000, Mr. Turley was the Minister-Counselor for Commercial Affairs at the U.S. Embassy in Beijing, and from 2000 to 2002 he served in the same capacity at the U.S. Embassy in Tokyo.

Alan Turley was educated in public schools in Cheshire Connecticut and was graduated from the University of Virginia with High Honors in 1983. After receiving his B.A., Mr. Turley spent two years studying Chinese in Taiwan at National Taiwan Normal University's Mandarin Training Center. During that time he also traveled extensively throughout Asia

Susanne T. Stirling

VICE PRESIDENT, INTERNATIONAL AFFAIRS



Originally from Denmark, **Susanne Stirling** studied at the University of Copenhagen and holds a BA in International Relations from the University of the Pacific, where she now serves as a regent mentoring students. She earned a Masters in International Relations at the University of Southern California. Studying International Affairs was a natural course for her and she finds it rewarding to work with these bright young minds - many of

them women - who will be the future in our world of International Trade.

Susanne Thorsen Stirling currently serves as the VP of International Affairs for the California Chamber of Commerce. Mrs. Stirling is an appointee of the U.S. Secretary of Commerce to the National Export Council, and serves on the US Chamber of Commerce International Committee, California International Relations Foundation, and the Chile-California Council. In previous years, Mrs. Stirling served on the Governor Edmund G. Brown Jr. to the California International Trade and Investment Advisory Council, and served on the Board of Directors of the International Diplomacy Council, the World Affairs Council of Northern California (Sacramento), the District Export Council (appointed by the U.S. Secretary of Commerce) and the Danish-American Chamber of Commerce.

When the California Department of Trade, Technology and Commerce closed over 15 years ago, an avenue of California's trade lane was also closed. During the Schwarzenegger Administration, the California Chamber of Commerce stepped up and started coordinating trade and investment forums and events in lieu of no official California trade agency. It was Stirling who was catalyst for keeping California's international trade and investment flame lit. In 2006-2007, she led efforts for the state to organize the first California Trade Partnership roundtables in Sacramento and continues to oversee the Council on International Trade (CIT), which serves as a communications sounding board for all things global trade and investment related.




Every year during World Trade Week, the third week in May, Susanne organizes an annual meeting for the California body of District Export Councils and then a global business forum featuring the state's most influential leaders on international business. In addition, Susanne organizes the annual Host Breakfast whereby Governor addresses the global state of trade for California while simultaneously honoring all of the foreign diplomats in

California. Susanne's commitment to California is not simply through the Chamber in Sacramento. She is a Northern California District Export Council member and she also has the Chamber's International Committee meeting every year in Southern California. Susanne has been involved with many California-led trade missions including most recently to Mexico where for the first time in over 15 years the state has re-established an official office for trade and investment in Mexico City. Susanne has been the consummate Californian when it comes to global trade and investment - she understands that California is connected to the world and must remain so as a leader and innovator of products and services that benefit not only Californians but the world alike.

Through the efforts of Mrs. Stirling, the California Chamber of Commerce is a recipient of the US President's "Excellence for Export Service Award," the nation's highest award to honor US exporters as well as the Presidential Citation from the government of the Republic of Korea for promoting US-Korea commercial relations.

Mrs. Stirling and her husband, former California state Assembly member, Superior Court Judge and Chief Deputy Attorney General, Dave Stirling, Vice President for Pacific Legal Foundation and daughter, Mikaela reside in Walnut Grove.

Through her excellent leadership in International Trade, WIT Los Angeles would like to honor her as the "Outstanding Woman of the Year."









GLOBAL TRADE EDUCATOR OF THE YEAR

Amy Grat

Ms. Amy Grat, Chief Executive Officer of EXP (formerly International Trade Education Programs (ITEP), has been an integral part of expanding this non-profit organization based in Long Beach, CA which was established to bridge the gap between the Port international trade industry's need for a skilled workforce and local high school's struggles to find programs to graduate students that enabled them to enter the workforce with a skill as opposed to college entrance.

Amy's service as an educator is a result of being a daughter of a teacher and a nurse, professionals with passion for supporting the community. During her professional career path, from teaching English as a Second Language in college, to training companies to being able to compete more effectively in a global market, to introducing high school students to highwage, high-growth careers in Port-related industries — the common denominator has always been to connect an individual with an opportunity. Over these years, Amy has delivered educational programs and creating sustainability through fundraising for EXP, making both sides of the equation work.

Amy was introduced to international trade while studying at college when her parents rented her room out to a Japanese student studying English at their local university. Global trade education is a critical service for the international trade industry to expand its skilled workforce, and in fact helped Amy's parents pay for her college. This experience opened her eyes to the world of opportunities beyond the boundaries of her city, state, and country.

Amy was a member of the International 4-H Youth Exchange (IFYE) program and was assigned as cultural ambassador on behalf of the United States to Costa Rica for six months to promote California agriculture. This experience fueled her desire to work abroad and save the world, and she ultimately was accepted to Elliott School of International Affairs at The George Washington University in their Master's Program in International Economic Development.

After graduation, Amy volunteered at the International Visitors Council of Philadelphia in the global trade industry (Wilmington, DE) and later as a study abroad advisor at the University of Pennsylvania where she prepared hundreds of UPenn undergraduates to study abroad in countries ranging from Argentina to Zimbabwe over the next four years. While working at University of Southern California, where she

graduated with an MBA from the Marshall School of Business, she did similar work preparing executives to be more effective in cross-border business through directing programs and conferences such as the Asia Pacific Business Outlook with the goal to expand the global trade education industry while providing skilled workforce to the business and international trade community.

While working at the Los Angeles County Economic Development Corporation (LAEDC), Ms. Grat was introduced to former Port of Los Angeles Commissioner Carol Rowen – then founder of EXP. She started assisting ITEP through raising funds for Phineas Banning High school students in Wilmington and opening doors to international trade. Four years as a volunteer led to nine years as CEO. During 2018-2019, over 400 industry volunteers helped EXP serve 6,400 high school students at 9 Southern California high schools by bringing schools and industry together. EXP, under Amy's leadership, is creating new ways of learning, knocking down barriers and bringing genuine opportunity to every student within their reach – all the while expanding the pool of prepared students for the international trade industry.

Ms. Amy Grat is a true role model and highly respected for her significant achievements in the international trade industry as well as a fabulous mentor and educator. Due to the impact Amy has had on global trade education for over the past decade, we have chosen her to receive the Global Trade Educator of the Year Award 2019.

Kollyn Kanz is Senior Vice Pesident of HSBC Bank in Los Angeles California in the Global Trade and Receivables Finance division.

WIT-LA Past President and member of over 20 years, Kollyn D. Kanz is a graduate of Thunderbird School of Global Management, Phoenix AZ, and has also served in WIT-LA positions of Chair of the Board, Vice President,

Treasurer, and has been a steady and constant mentor and engaged advisor to successive WIT-LA Board Members through the years. Always willing to help with the current project at hand, Kollyn rarely turns down a request for help or advice and there has been many occasions in which her insight and experience has been extremely helpful for the current WIT-LA Board of Directors.

Kollyn states "I will be forever grateful to WIT-LA for all of the great friendships, business connections and opportunities to serve our community. The ability to support women in trade is inherently international. The depth and breadth of the organization is as inspiring as it is impressive in its reach."

In 1992, Kollyn was first introduced to Women in International Trade while studying for her MBA. During her first job out of grad school in the International Department of the Atlanta Chamber of Commerce, she became a member of the local WIT chapter. It was a wonderful way to meet women and men in various fields of international trade, including banking, logistics and law. A few years later when she arrived in New York to work at FCIA (Foreign Credit Insurance Association), she once again got involved with the local aWIT chapter. As always, it was a tremendous way to make connections and stay keyed in to the local international trade community. So it is no surprise that when she made her next move, to

Los Angeles, she reached out to WIT-LA for connection. It was a WIT-LA board member who helped her network into a job at Imperial Bank. Her first job in banking led to the eventual career in International Trade Finance with various banks including Wells Fargo, US Bank and currently HSBC (Hong Kong Shanghai Bank).

After initially serving on various committees for WIT-LA such as Newsletter and Scholarship, she moved on to various board roles including Treasurer (her favorite after Scholarship), VP. President and finally Chair. Kanz represented WIT-LA at the national level with OWIT in various cities including Washington, D.C., Dallas, and Chicago. WIT-LA was a pathway to career advancement, wonderful friends and an opportunity to give back through various charitable endeavors of the organization. In addition to the Scholarship Committee, the organization supported Clothes the Deal and Room to Read. On a trip to Cambodia with her husband, they were fortunate to be invited to a Room to Read camp where they were teaching young girls about the importance of education along with numerous life skills to help them succeed in the face of multiple obstacles.

The event not only featured representatives from different international trade agencies and organizations in Southern California but also were well attended by many of the local chamber members ~ breaking the norm that local chamber members are either too small or indifferent about international trade.

In addition, realizing there are many manufacturers in Southern California that are not aware of international business opportunities, the idea of "Manufacturers' Roundtable" came to Ms. Young's mind. In August 2015, with the help of the City of Santa Ana and Santa Ana Chamber of Commerce, the first of the series of Manufacturers' events was held in Santa Ana and attended by less than 20 people. In 2016, she brought the idea to Cities of National City, Poway and Murrieta - the first of its kind in Poway and National City. National City Mayor Ron Morrison even personally took on a role to organize the event. To enhance the idea, additional elements like experience sharing by other successful manufacturers with international experience as well resources by various agencies were added to the other manufacturers' events since. In 2018, the program was brought to the Cities of Brea and Corona, followed in 2019 by three manufacturers' events held in Garden Grove, Torrance and Glendale. While traditionally challenging to get manufacturers to leave their doorstep, with Betty's persistence and steady influence, the number of attendees has been steadily increasing.
