




Ambassador Nina Hachigian

Los Angeles Deputy Mayor for Foreign Affairs

Hachigian, an L.A. resident who served as U.S. Ambassador to the Association of Southeast Asian Nations (ASEAN) in the Obama Administration, will lead the newly-created Mayor's Office of International Affairs. The office will work to broaden the city's global engagement on matters ranging from trade, investment, culture, and tourism to preparations for the 2028 Olympic and Paralympic Games.



Extraordinary and Plenipotentiary. During her tenure, the U.S. established a strategic partnership with ASEAN, held the first Leaders' Summit in the United States, launched a presidential initiative on economic cooperation, established the U.S.-ASEAN Women's Leadership Academy, and grew the youth program to over 100,000 members. She had previously served as director of the RAND Center for Asia Pacific Policy for four years, been Senior Vice President at the Center for American Progress, and was on the staff of the National Security Council in the Clinton White House from 1998 to 1999.

A founder of Women Ambassadors Serving America (WASA), Ambassador Hachigian holds a B.S. from Yale University and is a graduate of Stanford Law School. She is the editor of "Debating China: The U.S. – China Relationship in Ten Conversations" (Oxford University Press, 2014), and co-author of "The Next American Century: How the U.S. Can Thrive as Other Powers Rise" (Simon & Schuster, 2008).

The office headed by Hachigian will oversee and coordinate all of the city's international affairs — including advising the Mayor on trade policy and opportunities, attracting global investment, assisting the Host Committee with preparations for the 2028 Olympic and Paralympic Games, and managing relationships with global leaders. She will assume the post on Sept. 6.

Hachigian was appointed U.S. Ambassador to ASEAN by former President Obama, and served in the post from 2014 to 2017 with the rank and status of Ambassador

Commissioner Velasco is a sole practitioner estate planning attorney in Playa del Rey. As a civic leader, she has served as Lieutenant Governor for Rotary International District 5280 and currently serves as a Fee Dispute Arbitrator for the State Bar of California. She also served as chair of the Los Angeles Area Chamber of Commerce World Trade Week in 2012.

Commissioner Velasco has served as a City of Los Angeles Planning Commissioner, Staff Legal Counsel and Hispanic Liaison to former City Councilman



Michael Woo, Assembly Aide/Hispanic Liaison to former Assemblyman Mike Roos and a bilingual elementary school teacher.

Commissioner Velasco earned a Juris Doctorate from the University of West Los Angeles School of Law, a Master of Arts degree in education from Claremont Graduate School, and Bachelor of Arts degree from California State University, Long Beach.

Commissioner Velasco has held the position of vice president of the Board of Airport Commissioners since September 14, 2005. She is a native Californian, born at California Hospital in Los Angeles, and has lived with her husband Frank in Playa del Rey since 1988.

A proven leader in Maritime-based Trade, Transportation and Infrastructure, Kristin Decas repeatedly demonstrates her ability to build vision and implement strategy through open, collaborative processes that foster results. This year, she was named Top Port Director of the Year for 2017 by the International Association of Top Professionals!

Since beginning her tenure with the Port of Hueneeme in February 2012, the Port has realized several successes. The total tonnage for FY 2013 jumped to over 1.4 million metric tons marking the Port's most active trade year since its inception in 1937. The Port also turned a significant corner in FY2013 achieving its strongest fiscal numbers in history at over \$13million in gross operating revenue. Kristin championed the first annual Port Banana Festival, drawing over 10,000 visitors to the Port. The Port of Hueneeme related activities generate \$1 billion in annual economic impact and create more than 10,200 direct, indirect, induced and influenced jobs.

Prior to serving for the Port of Hueneeme, Kristin served as CEO and Port Director for the Port of New Bedford, MA, the nation's number one value fishing port. In 2007, when Kristin took the helm as the director for the Port, she inherited a \$200,000 deficit. Kristin literally 'cleaned up' the financial and physical landscape. During her five years at this post, she orchestrated a complete fiscal turnaround; from 2008, and every year thereafter, her prudent fiscal management generated a healthy profit for the Port. Kristin played a vital role in the development of a new terminal to support the nation's first offshore wind energy project. Under her leadership the Port also realized significant growth in cruise and recreational boating activity.

The maritime industry runs in Kristin's blood. Four generations ago, her great-great-grandfather was Harbormaster in Bergen, Norway, and her great-grandfather built clipper ships. While not her initial career path choice, life happened! With life coincidences and special mentoring, she now thrives

in the maritime industry and she is currently Director of the California Port of Hueneeme.

Kristin is recognized by Trade Administration officials for her impressive work in promoting economic development, and for her service on scores of federal level shipping and port committees. Most recently Kristin was awarded a high-profile appointment by the U.S. Department of Transportation to

both the National Freight Advisory Committee (NFAC) and the U.S. Marine Transportation System National Advisory Council (MTSNAC).

The board of directors of the American Association of Port Authorities (AAPA), a trade association representing more than 130 public port authorities in the US, Canada, the Caribbean and Latin America, elected Kristin as the association's chair for the 2014-2015 activity year.

Kristin was the first woman to run both the Port of New Bedford in its 50-year history and the Port of Hueneeme in its 78 years. She was the fourth woman to chair the Association of American Port Authorities in its 103 years. Kristin also supports her community by serving on the Dignity Health Ventura County Community Board and the Habitat for Humanity Ventura County Advisory Board. Earlier this year, containers of humanitarian aid set out from Port Hueneeme to Costa Rica, in partnership with Del Monte. Most recently she was named Maritime Executive of the Year at the Green Shipping Summit USA.

For all these reasons, Kristin Decas has been selected as WIT-LA's Outstanding Woman of the Year in International Trade!

Ms. Jasmin Sakai-Gonzalez is an exceptional ambassador to the trade for the Los Angeles Area Chamber of Commerce and is highly respected and connected with all the important members of the international trade community in Los Angeles. She has been instrumental in increasing the awareness of international trade and is respected and known as a true catalyst who makes things happen.



An inkling as to what has made her such a successful catalyst of trade and commercial diplomat, is that Jasmin, growing up as a child with a mixed ethnic heritage in Southern Germany, provided her with a deep appreciation for other cultures. That appreciation only deepened when she and her family moved to Southern California, where she immediately felt at home in a true ethnic melting pot.

Jasmin has been with the Los Angeles Area Chamber of Commerce for over 10 years currently holding the position of Director for the Center for Global Trade & Foreign Investment. She is a vital asset in growing relationships for members of the Chamber and for the extended Southern California Trade Community. Ms. Sakai-Gonzalez manages and implements the California State Trade Expansion Program Grant, has worked with the Governor's office promoting global trade missions on behalf of then Governor Schwarzenegger, and a true catalyst with all the international trade stakeholders in Southern California.

While global trade was not her initial career pathway, it was through her work at the L.A. Area Chamber that she saw the power that global trade had to connect the local business community with the immense opportunities abroad. For over a decade, she has strived to support California companies seeking to expand their markets by connecting them with partners abroad.

Ms. Sakai-Gonzalez has worked to advance global trade in the region and help local businesses build international relationships for over a decade. She serves as liaison between foreign diplomats, trade organizations and key partners, including government and business agencies at the local, state and federal level. Her business acumen is pristine and leads to positive results for all stakeholders.

Perhaps her most well-known body of work is her leadership of the World Trade Week Southern California initiative, an initiative of the L.A. Area Chamber, that dedicates itself to educating the public on the positive impact, importance and benefits of global trade on the local and national economy through a series of educational programs and events. She has been instrumental in increasing the awareness of trade with this World Trade Week Kickoff event, which attracted close to 1,000 attendees this year!

Jasmin has been an indispensable partner and team member critical in implementing several overseas exhibitions and trade mission for the California State Trade Expansion Program (STEP) covering automotive, aerospace, and medical equipment.

She has always been attentive to assist and promote all the trade organizations, including WIT-LA's trade programs and has key interest in trade education and scholarships for college students.

Jasmin is a shining star whose integrity, dedication and belief in expanding one's community has benefited countless entities in the international trade industry. The respect and appreciation she has received is well earned!

Dr. Noel Hacegaba is managing Director of Commercial Operations and Chief Commercial Officer for the Port of Long Beach, which is a major port in the United States and handles millions of containers entering and leaving the USA. He also handles all of the security functions of the Port of Long Beach.



Noel is always referred to as a "gentleman" and an astute business person. Noel is known for his support of women's rights and equal opportunity for women, especially in their career paths and equality in wages. Noel has embodied these attributes throughout his career and was an excellent choice for the "Guy Fox Special Award" given by WIT-LA. This is one reason why many people would like to work for the Port of Long Beach, as they know that their contributions will be recognized and they will be given equal opportunities.

Noel has made many presentations on the Port of Long Beach around the world promoting international trade and this does indeed create jobs that are desperately needed in Southern California. Noel has been a huge supporter of the International Seafarers Center, and the sailors, both men and women that visit our port complex, to make them feel at home. Without his support, the ISC would not be where it is today. He is especially concerned about the women seafarers, and wants to be sure that they are well taken care of and well protected.

Noel believes in a good education for everyone and not just a select few. He is a member of the Long Beach City College Foundation Board of Governors, and takes pride in addressing the students. Through Noel, the Port of Long Beach takes on interns to help support his promise to education.

Noel is a member of the Marine Exchange, which guides our ships into port, similar to air traffic controllers, so they can make sure that all of the vessels arrive safely at our ports. He works in conjunction with the United States Coast guard on vessel tracking with marine radar to help guide these giant vessels into our port complex. He is also on the Board of Directors of the Harbor Association of Industry and Commerce, and he is also on the Board of Directors for St. Mary Medical and a member of the Los Angeles Long Beach Propeller Club.

The "Guy Fox Special Award" is awarded annually in recognition of men who distinguish themselves through their efforts for empowering women in global trade, as Dr. Noel Hacegaba has done this throughout his Professional career and then some! In recognition of Dr. Hagegaba's contributions and efforts towards the advancement of international trade and professional empowerment of women locally, regionally, and worldwide we are very proud to award the "Guy Fox Special Award" to Dr. Noel Hacegaba, who will keep the standard high that has been set by Guy Fox for whom this award has been named.

Mrs. Lynnette Keffer is a female entrepreneur who over the course of 50 years has established herself as an innovative leader in the produce industry. Beginning her career in 1966 at a time when female business leaders were few and far between. Lynnette quickly became known as “the fruit lady” of the west coast. Generous and hard working, she made it a point to go the extra mile for her customers. Lynnette turned every challenge into an opportunity and built a successful niche business for the clearance of imported fresh perishable produce. Soon, produce importers were seeking out her services.

Freshlook, a tracking system designed to deliver maximum efficiencies and real-time information, essential to the industry as produce is not only perishable, it is often sold in a market where prices fluctuate daily. The Freshlook system provides produce importers with on demand visibility along with statistical data and trade document compliance management. It provides the status of the customs and partner government agencies release and terminal availability. To meet the time constraints and to enhance productivity, the system’s dashboard functionality enables the end user to navigate from global search and exception-based transactions to manage containerized and break-bulk cargo such that communications, efficiencies, and cargo movements are maximized and the occurrence of delays and damage are minimized.






